### Prior Service Grant

Promise of options was an inducement to change employers or Reward for years of service.

In Re Marriage of Nelson (1986) Cal App. 3d 150

$$\frac{\text{\# of Days from DOG to DOS}}{\text{\# of Days from DOG to DOE}} \times \text{\# of Shares}$$

### Current Services

Supplement employee compensation with deferred benefits.

In Re Marriage of Harrison (1986) 179 Cal. App. 3d 1216

$$\frac{\text{\# of Days from DOG to DOS}}{\text{\# of Days from DOG to DOV}} \times \text{\# of Shares}$$

### Future Services
